RETOTALLING FEE	: Rs. 400 per paper
REVALUATION FEE FOR FAILED CANDIDATES (UG)	: Rs. 600 per paper

REVALUATION FEE FOR FAILED CANDIDATES (PG)	: Rs. 1000 per course

ELIGIBILITY FOR RETOTALLING :	
Retotalling is permissible for all current semester theory courses and arrear theory courses.	
ELIGIBILITY FOR REVALUATION FOR FAILED CANDIDATES :	
1. Revaluation for failed candidates is permissible for all current semester theory courses ONLY .	
2. Revaluation for failed candidates in arrear courses is permissible for maximum of TWO arrear theory courses. (for current and Ex-final candidates only)	
3. Revaluation for failed candidates in arrear courses is permissible for any Number of theory courses. (for Extension candidates only)
